ADDENDUM NUMBER 1 TO GRANT AGREEMENT BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION (NORAD) AND THE ADVENTIST DEVELOPMENT AND RELIEF AGENCY (ADRA) NORWAY CONCERNING STRENGTHENING EQUITY, ACCESS AND QUALITY IN EDUCATION – SEAQE2, QZA-18/0353, PROJECT B; EDUCATION IN EMERGENCY UPPER NILE, SOUTH SUDAN

1. BACKGROUND

- 1.1. The Norwegian Agency for Development Cooperation (Norad), represented by the Department for Civil Society and the Private Sector, and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 29.5.2019 (the Agreement) concerning QZA-18/0353 Strengthening Equity, Access and Quality in Education – SEAQE2 2019-2023 (the Project).
- 1.2. The Grant Recipient has submitted a request to Norad dated 01.10.2019 regarding additional financial support to component Project B of the Project; Education in Emergency Upper Nile, South Sudan (Project B), with which Norad has decided to partly comply.
- 1.3. The Parties have agreed to amend the Agreement through this addendum number 1 (the Addendum), which shall be an integrated part of the Agreement.

2. EXTENSION OF THE SUPPORT PERIOD

- 2.1. The support period for Project B set forth in the Agreement 1.3 shall be aligned with the Support Period for Project A and thereby be extended to 29 February 2024 (the Support Period).

3. ADDITIONAL GRANT

- 3.1. Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, and this Addendum, provide an additional grant not exceeding NOK 50.880.000 (Norwegian Kroner fifty million eight hundred and eighty thousand) (the Additional Grant).
- 3.2. The Additional Grant shall be used exclusively to finance Project B “Education in Emergency Upper Nile, South Sudan” as specified in the budget included as Annex A to this Addendum, during the Support Period.
- 3.3. The Additional Grant shall be disbursed upon written request as described in the Agreement.
- 3.4. The full revised results framework is included as Annex B to this Addendum. The Grant Recipient shall submit for approval an updated results framework with baseline values and revised targets prior to the Additional Grant’s second disbursement in 2020.

4. REVISED CONDITIONS

4.1. The following shall be added to the Agreement's Specific Conditions:

Article 1.3: The Support Period for Project B shall be extended to coincide with the Support Period for Project A.

Article 2.1: The expected results of Project B are as follows:

The project's planned effect on society is: *All learners regardless of background, ability and gender, equitably access, engage in and learn in inclusive educational institutions*

The project's intended target groups are: *Conflict-affected children, including girls, children with disabilities and out-of-school children, Parents, Parent-Teacher-Associations, Teachers, Head teachers, local education authorities and Civil Society Actors.*

The project's planned effects for the target groups are:

Outcome 1: *More conflict affected children and youth access and participate in inclusive education.*

Outcome 2: *More children and youth learn in safe, protective and healthy education institutions.*

Outcome 3: *Learners benefit from improved quality teaching and relevant learning.*

Outcome 4: *Learners, parents, communities and other stakeholders are more positively engaged with educational systems.*

Outcome 5: *Strengthened civil society influences education policies and practices.*

The full results framework is included as Annex B to this Agreement.

Article 3.1: Due to the extraordinary situation created by the Covid-19 outbreak an updated implementation plan and budget covering the year 2020 shall be submitted to Norad by 1 September 2020. The implementation plan and budget shall include the content listed in article 1 of the General Conditions. The Civil Society and the Private Sector Department's standard formats shall be used.

Article 4.1: The tentative, annual distribution of the Grant will be as follows:

2020:	NOK 12 720 000
2021:	NOK 12 720 000
2022:	NOK 12 720 000
2023:	NOK 12 720 000

The annual allocations must be confirmed by Norad following the Parliament's approval of the state budget for the relevant budget year. Disbursements will be based on the actual financial need of the Project in accordance with article 5 of the Agreement.

Article 5.1: The second disbursement in 2020 shall be subject to Norad's receipt and approval of an updated budget and implementation plan for 2020, as per article 3.1.

Article 6.1: The requirements for Project A shall also be applicable for Project B for the Support period (for 2020; from April).

Article 9: The requirements for Project A shall also be applicable for Project B.

The following text shall replace General Conditions article 12 2. d): changes to the Project's annual budget that imply reallocation of more than 10 % of a budget line. Due to the extraordinary circumstances related to Covid-19, reallocation up to 20 % without pre-approval will be allowed for the year 2020.

5. REMAINING CONDITIONS OF THE AGREEMENT

5.1.1. All other provisions of the Agreement shall remain unchanged and in force.

6. ENTRY INTO FORCE AND DURATION

6.1. The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.

This Addendum has been signed in two -2- original copies in the English language, whereof the Parties keep one each. In the event of any discrepancies between this English language version and any later translations, the English language version shall prevail.
