ADDENDUM NUMBER 4

TO AGREEMENT GLO-3768 QZA-18/0353 BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION

AND

ADRA NORWAY

CONCERNING GLO 3768 – QZA-18/0353 STRENGTHENING EQUITY, ACCESS AND QUALITY IN EDUCATION 2 EMERGENCY 2021 (SEAQE2 – E21) – MYANMAR

1 BACKGROUND

- 1.1 The Norwegian Agency for Development Cooperation (Norad) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 29.05.2021 (the Agreement) as amended by addendum number 1 dated 25.06.2020, and addendum number 2 dated 23.08.2021, and addendum number 3 dated 08.11.2021 concerning QZA-18/0353 Strengthening Equity, Access and Quality in Education 2 (SEAQE2).
- 1.2 The Grant Recipient has submitted a request to Norad dated 16.08.2021 regarding additional financial support to the Project, with which Norad has decided to partly comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 4 (the Addendum), which shall be an integrated part of the Agreement.

2 ADDITIONAL GRANT

- 2.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement, including previous addenda, and this Addendum, provide an additional grant not exceeding NOK 10 million (Norwegian Kroner ten million) (the Additional Grant).
- 2.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum, during the Support Period.
- 2.3 The Additional Grant shall be disbursed in total upon signing of this Addendum.

3 ADDITIONAL CONDITIONS

- 3.1 The support period for the additional grant is 01.11.2021-31.05.2022.
- 3.2 Financial report, audit report and final report for the additional grant shall be submitted to Norad as part of the progress report for the agreement GLO-3769 QZA-18/0353 no later than 31.05.2023.

4 REMAINING CONDITIONS OF THE AGREEMENT

- 4.1 All other provisions of the Agreement shall remain unchanged and in force.

5 ENTRY INTO FORCE AND DURATION

- 5.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.
